Report of the PCC to Members of the Church

1. ADMINISTRATION

St. Margaret's Church is situated in the village of Underriver, Kent, in the Church of England Diocese of Rochester. The Reverend Serena Willoughby is the Vicar of St. Margaret's Underriver and St. Lawrence's, Seal Chart. Administrative information is set out on pages 1 and 2.

2. STATUS OF THE PCC

The Parochial Church Council is a body corporate (PCC Powers Measure 1956, Church Representation Rules 2011) and is a charity currently exempted from registration with the Charity Commission.

For the purposes of the Charities Act the members of the PCC are Trustees of the Church and all its property and are responsible for making decisions on all matters of general concern and importance to the parish including deciding how the funds of the PCC are spent.

3. APPOINTMENT OF PCC MEMBERS

The method of appointment of PCC members is set out in the Church Representation Rules. The current members of the PCC are set out on page 1. They consist of ex officio members, elected members and appointed members. Elected members are those who are elected at the Annual Meeting by those members of the congregation who are on the electoral roll of the church and attend. New PCC members are briefed on their responsibilities and the function and responsibilities of the PCC. The full PCC met five times during the year.

4. AIMS AND PURPOSES

The Parish

The population of the ecclesiastical parish is some 300 inhabitants.

The Joint Benefice

St Margaret's is a Joint Benefice with St Lawrence's Seal Chart. There is no Vicarage in Underriver. The Vicar lives at the Vicarage in St Lawrence's Parish. The Vicar and the licensed Reader serve both parishes.

The two parishes have for many years shared services and other events, both pastoral and social. This relationship was formalised in 2017. Gretel Wakeham is now the licensed Reader for both St Margaret's and St Lawrence's. Joint Benefice status encourages the two parishes to support each other and to share their strengths and talents and through joint services, special projects.

Mission Statement

The Mission Statement of the PCC is as follows:

"In St Margaret's Church we will show our love for God and our neighbours in our private prayers, in our public worship, in our care for our Church, in our friendships and in our service to our own and the wider community".

The PCC

The Parochial Church Council (PCC) has the responsibility of co-operating with and assisting the Vicar to promote the whole mission of the Church, pastoral, evangelistic, social and ecumenical in the ecclesiastical parish - involving the following areas of activity:

- Worship as worthy of God as we can offer it;
- Christian neighbourliness and outreach to those in our Parish;
- Maintenance of the fabric repairs and improvements of the Church and Churchyard;
- Cleaning, flower arranging, organising rotas, etc;
- · Giving to outside causes and charities and
- Financial provision for the above.
- Appointing sidesmen and women

PCC Members

PCC members are listed on page 1. As far as is possible, each Member has ongoing responsibility over one or more areas of the life of our Church.

5. ACHIEVEMENTS AND PLANS

Under the inspirational leadership of our Vicar the Reverend Serena Willoughby, our Church has had another very successful and eventful year. Gretel Wakeham (Licensed Reader), Maxine Clark (Churchwarden) have contributed hugely to this success, as have John Clemence (Treasurer and Clerk of Works), Arthur Rucker (Secretary) and Sophie Woods Scawen, who has continued to combine the posts of Benefice Administrative Officer and Parish Magazine Editor with Jennifer Fair as her commissioning editor. More detail is given in the Vicar's Report attached.

6. RISK MANAGEMENT

The major risks, to which the church is exposed, as identified by the PCC, have been reviewed and systems are in place to manage those risks.

7. FINANCIAL REVIEW

The Financial result for the year is summarised as follows:

- **7.1.** Total receipts amounted to £211,815 (2021 £58,834)
- 7.2. A total of £106,400 (2021 £44,611) was spent to provide the Christian ministry from St. Margaret's Church including the Diocesan Parish Share, which is the amount which the Parish pays to the Diocese to cover clergy costs, Diocesan overheads and a contribution to the work of the wider church.
- **7.3.** Donations to Charities totalled £34,491 (2021 £7,121).
- **7.4.** The net result for the year was an overall surplus of £105,415 (2021 £14,424) made up as follows:

General Fund Surplus £2,342 (2021 Surplus £4,571)

Organ fund Surplus £39,984 (2021 Surplus £4,492)

Repair Fund Surplus £63,089 (2021 Surplus £5,161)

The Unrestricted General Fund balance at 31st December was £32,810 (2021 £30,468)

7.5 Events

During the year fundraising events were held. The Harvest Festival service collection and lunch raised £1,193 for Christian Aid. The Christmas Market raised a total of £1,030 split between Crisis at Christmas and church funds.

Two concerts (one cancelled) raised a total of £7,235 for the Organ Fund.

In memory of Libby Notley an event was organised called "The Canterbury Trails". Money collected and raised by the church towards this project amounted to £2,821.

7.6. Appeals

An appeal was launched in December 2017 to celebrate the 150th Anniversary of the Foundation of St Margaret's. In the current year continuing regular donations arising from that appeal are divided equally between the General and Repair Funds.

During the year an appeal was launched for the support of Ukraine and refugees. A total with Gift Aid of £25,640 was raised in 3 weeks and £24,625 was distributed to The British Red Cross, Save the Children and UNICEF towards their relief programmes. £799 was provided in assistance to locally resident refugees and a balance remains of £1,216 for distribution including the proceeds of some fundraising events.

In October 2022 an appeal was launched to raise funds for 3 major projects and to request new or increased regular giving. The 3 projects are;

- the reordering of the West end of the church and the redecoration of the nave walls and ceiling. In addition, the PCC decided to order stacking chairs to replace the 3 rows of pews to be removed in the reordering and to replace the present shed with a larger one to enable the storage of chairs and other materials.
- the rebuilding and modernisation of the Walker organ and
- the refurbishment of all the church windows.

Faculties or List B agreement have been received for all the major works. The only outstanding matter is DAC approval for the chairs. A total of £120,306 including gift aid has been raised and grants have been awarded amounting to £20,000 from the Diocesan Missional Property Fund (£15,000) and the Friends of Kent Churches (£5,000). Work commenced on February 14th on the reordering and work on the windows will start in April, but the work on the organ may be delayed into 2024.

The PCC is enormously grateful for the generosity of many supporters of these appeals and those who have raised funds in previous years towards these projects.

8. RESERVES POLICY

8.1. The General Fund represents the reserves of the PCC that are not subject to any restrictions on their use and are available for the general purposes of the PCC. The reserves policy adopted by the PCC requires that the General Fund should be maintained at a minimum level of £26,000 (previously £21,000), which represents approximately 6 months' normal outgoings of the church and a £10,000 emergency reserve. At 31st December 2021 the fund balance was £32,810 (2021 £30,468).

8.2 Restricted Funds

The Organ Fund comprises money set aside for the repair of the organ and to defray major cyclical expenditure. In the current year fundraising for the Organ Fund raised £60,079 and repairs £580 were paid and a deposit of £20,000 towards the work to be done. The Organ Fund balance at 31st December 2022 is £70,357 (2021 £30,373).

The Church Repair Fund comprises monies set aside to meet future repairs to the Church fabric identified by the Quinquennial Inspection and other repairs as they arise and the reordering cost of the west end of the Church, the redecoration of the nave walls and ceiling and the cost of refurbishing the windows. The Church Repair Fund balance at 31st December 2021 is £78,099 (2021 £15,009). The next quinquennial inspection has taken place and the work required is due in 2023. The estimated cost of the work is some £14,000. During the year the 5-yearly inspection of the electrical installation also took place and as a result £5,335 was spent modernising the system and eliminating asbestos. A further £795 was spent making good the plaster and decoration of the vestry. Sums totalling £2,229 were spent updating the sound system in the church.

STATEMENT OF TRUSTEES RESPONSIBILITIES

Charity Law requires PCC members as Trustees to prepare Financial Statements for each financial year which give a true and fair view of the financial activities of the church during the year and of its financial position at the end of the year.

In preparing those Financial Statements, the PCC is required to:

- select suitable accounting policies and then apply them consistently
- make judgements and estimates that are reasonable and prudent
- state whether the policies are in accordance with applicable accounting standards
- prepare the Financial Statements on the going concern basis unless it is inappropriate to presume that the church will continue in operation.

The PCC is responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the church and which enable them to ensure that the Financial Statements comply with the Charities Act 2011. It is also responsible for safeguarding the assets of the church and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

ST. MARGARET'S CHURCH UNDERRIVER KENT NOTES TO THE FINANCIAL STATEMENTS YEAR ENDING 31st DECEMBER 2022

1. NOTES

1.1 Basis of Accounting

- The Financial Statements have been prepared under the historical cost convention.. The Financial Statements are in accordance with applicable accounting standards, the Statement of Recommended Practice, Accounting and Reporting by Charities (SORP FRS 102) and comply with the Charities (Accounts and Reports) regulations 2005 issued under the Charities Act 2011 and in accordance with the Church Accounting Regulations 2006 using the accruals basis.
- ii Fixed Assets comprising consecrated and beneficed property of any kind is excluded from the Financial Statements in accordance with s. 10 (2) of the Charities Act 2011.
- iii Moveable church furnishings held by the Vicar and Church Wardens on special trust for the PCC, which require a faculty for disposal, are accounted for as inalienable property unless consecrated and no value is attributable thereto. They are listed in the Church Inventory, which can be inspected at any reasonable time by application to a Church Warden.
- iv The cost of equipment used within the Church premises and all other items of equipment is written off when acquired.

1.2 **Restricted Funds**

- i The Dedicated collections fund represents collections and other donations for specified charities.
- ii Income is recorded when receivable.
- iii Expenditure is included in the Financial Statements on an accruals basis.
- iv Funds held by the charity are either:
 - <u>Unrestricted Funds</u> these are funds which can be used in accordance with the charitable objects at the discretion of the trustees or
 - <u>Restricted Funds</u> these are funds that can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular purposes. When Trustees use their discretion to transfer amounts to Restricted Funds the Trustees can subsequently transfer them back if no longer required.
- 1.3 **Going concern** -The Trustees consider that there are no material uncertainties about the ability to continue as a going concern.

1.4 <u>Trustees' remuneration and benefits</u>

None of the Trustees have been paid any remuneration or received any other benefits from the charity (2021 none).

1.5 <u>Trustees' expenses</u> - No Trustees' expenses were incurred in the year (2021 none).

1.6 Related party transactions

There have been no transactions with persons or entities that are closely connected to the charity or its trustees (2021 none).
